# **Exterior Doors - Security Systems 2023-24**

## Introduction

The Ava R-I School District is seeking proposals for upgrading the safety and security of exterior entrances to campus buildings. This will include crash bar setups for single and double doors, fob entry systems, and door buzzer systems. Proposals should include equipment pricing based on the information outlined in the General Requirements and Scope of Work Sections of this document.

## General Requirements

- 7x - Crash bar setups for double doors
- 3x - Crash bar setups for single doors
- 26x - Fob entry systems
- 4x - Door buzzer systems
  - Existing setups are Genetec and Axis

Materials must be delivered by April 18, 2024.

## Scope of Work

This project is the upgrade of existing exterior entrances with the addition of key fob entry systems and the integration with the existing door buzzer systems. Information on existing systems is available upon request.

## Response Instructions

Proposals must include pricing for equipment to upgrade existing entrances as described. Any additional recommendations from providers not outlined in the General Requirements and Scope of Work should also be listed as individual line items.

All pricing in proposals must be honored through the entirety of the project and this must be clearly stated in the proposal.

Received proposals will be opened and viewed publicly on December 15, 2023, at 4 pm at the Ava R-I District Administration Offices at 507 N. Spring Street, Ava, MO 65608.

The District's decision regarding the approval/denial of bids is based on various factors such as, but not limited to, quality, time constraints, and service. All decisions will be in the best interest of the District and shall be final.

Due to the nature and scope of this work, each bidder shall fully inform him/herself prior to bidding as to existing conditions and limitations under which the project is to be performed. No allowance shall be made to a bidder because of a lack of such examination or knowledge.

Proposals will be evaluated in the days following the opening to determine a recommended proposal to present to the Ava R-I Board of Education. Awarding of the recommended proposal will take place at a future scheduled Board of Education meeting.
